Heather Acheson, Humane Society Director, provided statistics for 2017 and noted she wrote three grants in 2017 for approximately \$75,000 and was currently working on another grant. Acheson said they have done a lot of upgrades to the facility. Acheson introduced their new Animal Control Officer, Eric Heinlein. Acheson said their next planned event is their "Adopt-A-Pet" day on April 7th at Orscheln's.

The bid specified approximately 25,000 tons of cold mix asphalt material, with the County furnishing all aggregate and asphalt oil. Using County specifications, the contractor will be required to mix asphalt at the County pit on South Washington, Great Bend. Venture Corporation provided the only bid at \$7.83 per ton. This is a .40 cent increase from 2017. Monies were included in the 2018 Budget for this anticipated expense.

Barry McManaman, County Engineer, said they advertised twice and sent letters to 5 contractors and noted Venture provided the only bid. McManaman said he reviewed bids from previous years for comparison and found that from 2015-2017, the bid was \$7.43 per ton.

CREATION OF A SECOND FIRE DISTRICT IN BARTON COUNTY, KANSAS PUBLIC HEARING NOTICE

- WHEREAS, the health and safety of County citizens is of utmost importance to the local governing units; and
- WHEREAS, it is vital to Barton County constituents that each governing body work with the others agencies to provide such services that are necessary to ensure the good health and well-being of all citizens and their property; and
- WHEREAS, a cooperative effort has been made by local governing bodies to determine a more effective and efficient method for delivering emergency response related to fire suppression, prevention and education.
- NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Barton County, Kansas, that:
- **FURTHER**, it is advisable and in the public interest that a Fire District consisting of the Townships of Albion, Eureka, North Homestead, South Homestead and Union and the Cities of Hoisington, Olmitz and Susank be organized in the Barton County for the protection of lives and property from the hazards of fire.

- **FURTHER**, a copy of this Resolution shall be published in a newspaper published and of general circulation in the area where the lands are located and in the official County newspaper once a week for three consecutive weeks. The aforementioned Public Hearing shall be held not less than 10 days after the date of last publication. A map of the proposed district, included as Attachment A, shall be published with this Resolution.
