B. RESOLUTION 2022-04: A Resolution of Barton County, Kansas, Approving the Execution and Delivery of an Agreement to Release and Assign the County's Opioid Claims to the Kansas Attorney General and Certifying Costs Attributable to Substance Abuse and Addiction Mitigation in Excess of \$500:

-Patrick Hoffman, County Counselor, will provide details on this item. On October 26, 2021, the Commission opted in to the National Opioid Settlement. The proposed settlement includes McKesson, Cardinal Health and AmerisourceBergen (Distributors) and Janssen Pharmaceuticals and its parent company, Johnson & Johnson (Janssen). The Kansas Attorney General requests a Resolution be adopted releasing and assigning claims to that office.

Pat Patzner, Director of Operations, said settlements require distributors to pay up to \$21 billion over 18 years and Janssen to pay up to \$5 billion over 9 years. Monies to be used to remediate and abate the

tracts of the opioid crisis. The Attorney General will determine funding allocations. Barton County was required to register electronically by January 2, 2022. Additional documentation may include approval of a participation agreement, release and resolution. The Attorney General has asked that all governmental entities pass this resolution.

Commissioner Schartz moved to adopt Resolution 2022-04, A Resolution of Barton County, Kansas, Approving the Execution and Delivery of an Agreement to Release and Assign the County's Opioid Claims to the Kansas Attorney General and Certifying Costs Attributable to Substance Abuse and Addiction Mitigation in Excess of \$500.

Commissioner Esfeld seconded the motion.

C. RESOLUTION 2022-05: 2022 Tax Sale:

-Jim Jordan, County Treasurer, will provide details. Resolution 2022-05 authorizes certain tracts of real estate be sold for back taxes. This money is then distributed to the various taxing entities in the County. The Resolution also authorizes abstract work be performed in preparation for the tax sale.

Jim Jordan, County Treasurer, said after a 2-year break, we will have a Tax Sale this year at the Great Bend Events Center. Jordan asked for adoption of the resolution and added after adoption, they will start charging the \$80 abstract fees.

Commissioner Daily said in the past they had set up payment plans for taxpayers and asked Jordan how many parcels he thought may be redeemed prior to the sale. Jordan said there were currently 181 parcels and he anticipated to be down to 90-100 by the tax sale.

Commissioner Hutchinson asked Jordan the date of the tax sale. Jordan said October 11th, second Tuesday in October.

Commissioner Krier asked Jordan if the money received from the tax sale goes into the general fund. Jordan said it does, it goes back to pay the taxes on the property. Anything left over goes to the general fund. Usually nothing is left to go to the general fund as anything over and above the taxes goes back to the owner. The only thing to go to the general fund would be any fees collected.

Commissioner Krier asked Jordan if the remaining would be disbursed to the other taxing entities, Jordan said yes.

Commissioner Daily moved to Adopt Resolution 2022-05, for the 2022 Tax Sale.

Commissioner Schartz seconded the motion.

All voted aye. Motion passed.

D. 2022 TAX SALE: First American Title Company:

-Pam Curtis, First American Title Company, will provide details. Jim Jordan contacted First American Title Company reference abstracting services for the 2022 Tax Sale. First American Title Company is willing to provide the needed services at \$80.00 per parcel.

Pam Curtis, First American Title Company, said for several years now they have supplied the Treasurer's Office with the needed certificates to notify all of the lienholders and property owners on the delinquent real estate parcels. Charges at \$80 per parcel.

Commissioner Hutchinson asked Curtis if the county loses \$80 per parcel for any that sell for more than is owed. Curtis said any parcels that are redeemed, the owner would pay the \$80.

Commissioner Esfeld said First American Title has always done a good job. She had seen things not done properly in another county.

Commissioner Schartz asked if the rate was a change from the past. Curtis said the same as in the past.

Commissioner Hutchinson asked if a property was sold for more than was owed, anything above go back to the owner, does the county get the \$80. Jordan said that was correct.

Commissioner Esfeld moved to approve the \$80.00 per parcel price for abstracting work provided by First American Title Company for the 2022 Tax Sale.

Commissioner Daily seconded the motion.

E. RESOLUTION 2022-06: State of Kansas, Municipal Investment Pool and Rescinding Resolution 2020-14, Same, adopted, August 24, 2020:

-Jim Jordan will provide details. The Commission will consider a revision to a 2020 Resolution allowing County funds to be pooled and invested. Revisions include the names of persons "authorized to transfer funds for investment in the Municipal Investment Pool (MIP) and are each authorized to withdraw funds, to issue letters of instruction, and to take all other actions deemed necessary or appropriate for the investment of funds".

Jim Jordan, County Treasurer, said this was just a housekeeping item. Matt Patzner had been a signer on accounts before Jordan had a deputy. Paige Volkel is his deputy and will be adding her as a signer.

Commissioner Schartz moved to adopt Resolution 2022-06, State of Kansas, Municipal Investment Pool | Rescinding Resolution 2020-14, Same, adopted, August 24, 2020.

Commissioner Daily seconded the motion.

All voted aye. Motion passed.

F. INFORMATION TECHNOLOGY: Wireless Door and Alarm System:

-Dereck Hollingshead, Information Technology Director, will present details. The Information Technology Department released a Request for Proposal (RFP) for an upgrade for five (5) doors with access control for Juvenile Services. Nex-Tech Security submitted the only bid of \$9,004.80.

Dereck Hollingshead, Information Technology Director, said since 2018 Barton County has used access control throughout most of the county facilities. Slowly expanding the number of doors with access. Since taking over the space formerly occupied by Cottonwood Extension Council, looking to secure 5 more doors for Juvenile Services. Asking approval to secure those with access control.

Commissioner Daily asked if the money was only for hardware. Hollingshead said that was correct. He will provide all the labor himself.

Commissioner Daily moved to approve the \$9,004.80 bid from Nex-Tech Security for the Wireless Door and Alarm System project. That amount is to be paid from the Equipment Replacement Fund, Equipment Replacement – General Line, 072-00-6380.

Commissioner Esfeld seconded the motion.

All voted aye. Motion passed.

G. INFORMATION TECHNOLOGY: Camera Surveillance Upgrade project:

-Dereck Hollingshead will provide details. The Information Technology Department released a Request Proposal (RFP) for this project that includes the upgrade of a camera server, various interior cameras video decoders. Two bids were received.

reck Hollingshead, Information Technology Director, said there are surveillance cameras in various county locations. The current server is approximately 7 years old and due to be replaced. Requested bids for the server, a few interior cameras that need to be replaced, an additional camera for the elevator and video decoders. Received 2 bids, one from Nex-Tech and one from another vendor. The second bid did not meet the requirements. Asked for approval of Nex-Tech bid.

Commissioner Daily asked Hollingshead if he was doing the installation and if this server was located in IT. Hollingshead said he will be doing installation and this server was located in their office.

Commissioner Daily asked where they would be monitored from besides IT. Hollingshead said that varied with different cameras.

Commissioner Hutchinson said in his experience with servers, you replace them when you have the funds or in a rush with whatever you can find at the time.

Commissioner Daily asked if there would be audio with the new cameras. Hollingshead said some of them will have audio depending on location.

Commissioner Schartz moved to accept the \$13,705.87 bid from Nex-Tech Security for the Camera Surveillance Upgrade project. Bid cost to be paid from the Equipment Replacement Fund, Equipment Replacement – General Line, 072-00-6380.

Commissioner Daily seconded the motion.

All voted aye. Motion passed.

H. APPRAISER'S OFFICE: Vehicle Replacement:

andy Prosser, County Appraiser, will provide details. After following County procurement policies and receiving no response to the bid, the Appraiser's Office was given a list of specifications and authorized to find a like vehicle within a multi-County area. This was classified as non-competitive procurement. With current vehicle shortages and staffing demands, the purchase was necessary for the continuity of operations. A 2019 Chevrolet Traverse with 22,363 miles was purchased from Hays Chevrolet for \$47,119.00 on January 13, 2022. The Commission will be asked to ratify the purchase.

Wendy Prosser, County Appraiser, said the 2006 Chevrolet Trailblazer was totaled in an accident last October. Insurance paid \$7,120.73. This vehicle was in the replacement plan for 2022, with the lack of available vehicles and the current market, Prosser did not plan to replace it this year. However, to meet deadlines and job requirements, they needed to acquire a vehicle. An RFP was put out for a 2019 or newer vehicle with less than 25,000 miles and third row seating. No bids were received so Prosser reached out to all local dealerships but there was nothing available locally. Prosser found a 2019 Chevrolet Traverse meeting the specifications in Hays and purchased it with bumper-to-bumper extended warranty for \$47,119.00. Asked the commission to ratify the purchase.

Commissioner Hutchinson noted that this commission puts a high priority on spending taxpayer dollars locally, within the county. This was extenuating circumstances.

Commissioner Schartz said Hays is regional for Barton County.

Prosser said with the number of miles they put on a vehicle in a year, mileage was a big factor.

Commissioner Esfeld said other departments occasionally use the Appraiser's vehicles, it will serve the county well.

I. CENTRAL KANSAS COMMUNITY CORRECTIONS: Fiscal Year 2021 Year-End Outcomes:

-Amy Boxberger, CKCC Director, will present. The Kansas Community Corrections Act provides grants to Kansas Counties to develop and maintain a range of programs for adult offenders assigned to Community Corrections agencies. A Comprehensive Plan (grant application) was submitted that set the goals for FY2021. The Year-End Outcomes then sets out the results at the close of the year and require the review and approval of the Barton County Commissioners, as the Administrative County for the District to which the plan pertains.

Amy Boxberger, CKCC Director, said State of Kansas had transitioned to a new database in April, 2021. This resulted in a delay receiving data. Their report goes from July 1, 2020 to April 17, 2021. The main goal was to have no more than 25% of case closures go into the Kansas prison system. During the reporting period there were 157 probationers discharged from the program. 23 of those or 15% were revoked, entering the prison system. 134 or 85% did not enter the system. Proud of the outcome. They have a culture of helping people make true change in their lives to make a safer community for everyone.

Commissioner Esfeld asked Boxberger the average time a person would be reporting to them. Boxberger said she could they have changed some of their processes. They used to extend people for nonpayment of court costs until it was paid, or we reached a 5-year limit. The longer someone was on supervision, the more likely that there were more problems. Trying to keep on task with the period the court orders and push them into different interventions to help them change their lives. Boxberger said that persons committing new felony charges having to do with distribution, sale of drugs, person crimes, gun crimes, they are asking for revocation. Outcomes are important but public safety was number one priority.

Commissioner Esfeld applauded Boxberger and her staff.

Boxberger said she knew 3 people who lost their lives to SUD, Substance Use Disorder. That was a difficult part of the job.

Commissioner Daily said they were doing a fantastic job.

Commissioner Daily moved to approve the Fiscal Year 2021 Year End Outcomes Report for Central Kansas Community Corrections and authorize the Chair to sign grant forms as necessary.

Commissioner Esfeld seconded the motion.

All voted aye. Motion passed.

ADDED ITEM J. DISCUSSION OF NEXT MEETING JANUARY 26th, 2022:

Commissioner Esfeld said Government Day is next Wednesday, January 26th in Topeka. The commissioners have a full schedule that day from 1:00 – 7:00. They need to be there and stay on top of a lot of legislation that will impact our citizens. Did not want to rush an agenda meeting the same day and asked the other commissioners their thoughts on not having a meeting that day.

Commissioner Hutchinson said they committed to Government Day prior to the agenda meeting change.

Commissioner Daily suggested if weather was a factor next Wednesday, a regular agenda meeting could possibly still be held.

RESOLUTION 2022-04

A RESOLUTION OF BARTON COUNTY, KANSAS, APPROVING THE EXECUTION AND DELIVERY OF AN AGREEMENT TO RELEASE AND ASSIGN THE COUNTY'S OPIOID CLAIMS TO THE KANSAS ATTORNEY GENERAL AND CERTIFYING COSTS ATTRIBUTABLE TO SUBSTANCE ABUSE AND ADDICTION MITIGATION IN EXCESS OF \$500.

WHEREAS, in 2021, the Kansas Legislature enacted HB 2079, the Kansas Fights Addiction Act (the "Act"), authorizing litigating municipalities such as the County of Barton to access opioid litigation settlement funds and become eligible for certain state grants by entering an agreement releasing the county's opioid litigation claims to the Attorney General and assigning any future opioid litigation claims to the Attorney General (the "Agreement"); and

WHEREAS, the County of Barton sustained damages related to the opioid epidemic; and

WHEREAS, the County of Barton desires to enter an Agreement releasing and assigning its Claims to the Attorney General in order to access opioid litigation settlement funds and become eligible for certain state grants;

BE IT RESOLVED BY THE GOVERNING BODY OF THE COUNTY OF BARTON, KANSAS:

Section 1. Authorization of the Agreement. Barton County hereby authorizes the release of its legal claims arising from covered conduct to the Attorney General, and the assignment of any future legal claims arising from covered conduct to the Attorney General, pursuant to the Agreement by and between the Attorney General and the County in substantially the form presented to and reviewed by the governing body at this meeting (copies of this document shall be on file in the records of the County), with such changes therein as shall be reviewed by the County Counselor and the officials of the County executing such documents.


Section 2. Execution of the Agreement. The Chairperson of the Board of County Commissioners, County Counselor, and County Director of Operations are hereby authorized and directed to execute, seal, attest and deliver the Agreement in substantially the form presented to and reviewed by the governing body at this meeting and such other settlement agreements, documents, certificates and instruments as may be necessary and desirable to carry out and comply with the intent of this Resolution, for and on behalf of the County.

Section 3. Certification of Costs and Expenses. The County hereby certifies that it has incurred costs and expenses related to substance abuse or addiction mitigation in excess of \$500 and the County can utilize the opioid litigation settlement funds for the lawful purposes established in the Kansas Fights Addiction Act and the settlement agreements. The County Counselor and County Director of Operations are hereby authorized to execute, seal, attest and deliver such other documents, certificates and instruments as may be necessary and desirable to certify these costs and expenses or similar costs and expenses, for and on behalf of the County.

Section 4. Effective Date. This Resolution shall be in full force and effect from and after its adoption.



RESOLUTION 2022-05
2022 TAX SALE

WHEREAS, Barton County holds certain tracts where taxes remain unpaid, which are eligible for Tax Sale and which the County Treasurer has determined should be subject to a Tax Sale; and

WHEREAS, it is in the best interests of the taxpayers of Barton County that delinquent property taxes be collected on these parcels.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Barton County, Kansas, that the County Counselor is directed to institute an action in the District Court of Barton County, Kansas, in the name of the Commissioners, against the owners or supposed owners of the real estate and all persons having or claiming to have any interest therein or thereto; and

BE IT FURTHER RESOLVED that the abstracting work associated with the sale be performed by First American Title Company; and

BE IT FURTHER RESOLVED, for the current Tax Sale, interest, penalties and the actual cost of the abstract fee shall be assessed to the identified parcel and must be remitted to the Treasurer prior to dismissal from the Tax Sale; and

BE IT FURTHER RESOLVED that the Sheriff of Barton County, a member of his staff or another person designated by the Sheriff may bid on property at the tax foreclosure sale in the name of Barton County, but that the bid of Barton County may not exceed the amount of the judgment lien and interest thereon, as provided by law, plus the costs, charges and expenses of the proceedings and sale as set forth in the execution or order of sale; and

BE IT FURTHER RESOLVED by the Board of Commissioners of Barton County that the Sheriff of Barton County is authorized to retain the services of an auctioneer to assist in the sale of real estate at the forthcoming real estate tax foreclosure sale for compensation as the Sheriff of Barton County deems reasonable.
