B. 2022 AUDIT REPORT:

-Jami Benyshek, Senior Audit Manager, AdamsBrown, will present the 2022 Audit Report to the Commission. The report will cover the financial condition of Barton County from January 1, 2022, through December 31, 2022.

Jami Benyshek, Senior Audit Manager, AdamsBrown, said Barton County had an unmodified opinion on the audit report. This means it was a clean audit opinion which was the best type of opinion they could issue. 2022 ended with \$25,157,000 of unencumbered cash.

Commissioner Zimmerman said it was interesting that the year started with \$22 million and ended with \$25 million.

Benyshek said a lot of that was due to the ARPA funding received in 2022 but had not yet spent. There was one statute violation noted. The Solid Waste Fund went over budget authority. There was no repercussion, they just had to note it. Because over \$750,000 was spent in 2022, a single audit had to be performed as well. They looked at the Coronavirus State and Local Fiscal Recovery Fund. There were a couple of significant deficiencies. Some payroll allocations were incorrectly applied to a grant, the total was \$156. It was a very small amount, but the Federal Government requires them to note it. The second item was reporting, making sure that all reports submitted were complete and accurate. A couple of audit recommendations: that offices taking money to the Treasurer be sure that their report matches the Treasurer's report and review retention policies for all types of records.

Commissioner Hutchinson said \$156 discrepancy was not too bad.

Commissioner Reif moved to accept the 2022 Audit Report as submitted by AdamsBrown. Commissioner Schlessiger seconded the motion. All voted aye. Motion passed.
