B. COUNTY CLERK'S OFFICE: RFP - Bulk Mailer for Revenue Neutral Rate Notices:

-Ms. Schmeidler will provide details. The "revenue neutral rate" is the property tax rate in mills that would generate the same property tax revenue in dollars as levied during the previous tax year using the current tax year's total assessed valuation. All Kansas counties are required to mail every property owner an estimated tax notice with information relative to each specific property's taxes and the revenue neutral rate (RNR) compared to the proposed rate for each taxing subdivision. The Clerk's Office solicited proposals for the bulk mailing of the notices as prepared in cooperation with area taxing entities. The approximately 15,000 – 16,000 notices, as prepared through the CIC program, must be mailed by August 10, 2023.

Bev Schmeidler, County Clerk, said two bids were received, from Postalocity and Data Integrators. The Data Integrators bid was incomplete. Postalocity did the RNR mailers last year and did a good job. Requested approval of the bid from Postalocity.

Commissioner Schlessiger moved to approve the estimated bid of \$16,094.51 from Postalocity for the Bulk Mailer for Revenue Neutral Rate Notices. Authorize the Administrator to encumber up to \$18,000.00 for the mailing from the Clerk's Account of the General Fund, Professional Services Line, 001-04-5475. Commissioner Reif seconded the motion. All voted aye. Motion passed.

C. HEALTH DEPARTMENT: Remodel of Bathrooms and Doorways:

-Karen Winkelman, Health Director, will provide details. In 2022, the Health Department accepted proposals for the remodel of certain areas of the Health Department to provide for a decontamination and washer / dryer area and to provide a meeting room better suited to larger meetings when dealing with HIPPA-related topics. Brentwood Builders submitted the only proposal at a bid of \$70,928.00. That bid was approved, with \$60,000.00 to be paid through the ELC Grant and \$10,928.00 from the Health Fund. The ELC Grant may now be used to cover the entirety of the remodel cost.

Karen Winkelman, Health Director, said the remodel was a result of COVID and they have really appreciated the new areas. They originally budgeted \$50,000.00. After discussion with the commissioners, they reached out to KDHE and asked for an additional \$10,000.00 which they granted. Winkelman and Misty Trudeau worked with KDHE and they agreed to fund the remaining \$10,928.00 so the entire project was supported by grant funds. Winkelman asked for approval to pay it with grant funds and return the money to the Health Fund.

Commissioner Hutchinson said he was glad they had done the project.

Winkelman said they had been out on environmental visits and had used the decontamination area several times. A recent situation had several other entities helping and Winkelman felt fortunate that they could open the area to partners as well.

Commissioner Zimmerman was appreciative of the extra effort to get the additional grant funds.

Commissioner Schlessiger moved to update the \$10,928.00 – Health Fund, Other Contractual Services Line, 006-52-5465, expenditure to Brentwood Builders for the Health Department Remodel to the ELC Grant, Other Contractual Services Line, 006-73-5465.

Commissioner Esfeld seconded the motion.

All voted aye. Motion passed.
