Included in the project are both the new hospital and new housing area. The Commission approved \$300,000.00 in financial support and directed the County Counselor to develop a Memorandum of Understanding reference the administration of the funding. The Memorandum of Understanding was adopted October 26, 2022. As the project will not be completed by the original end date, it is suggested that the complete date be extended to July 1, 2024.

Chris Komarek, Ellinwood City Administrator, presented details and asked for an extension until July 1, 2024. They had a meeting yesterday with some property owners, it was a great meeting and he felt they were making great strides.

B. RESOLUTION 2023-23: Resolution for Approval of Conditional Land Use Permit for a Described Tract of Land:

-Judy Goreham, Environmental Manager, will present details. VB BTS II, LLC by Network Connex; Victor McAlister made application for a conditional land use permit for a 385' Guyed Communications Tower on a portion of a tract owned by the Patricia K. Haberman Trust and located at 673 B N US 281 HWY, Great Bend, Kansas. The Barton County Planning Commission held a Public Hearing on September 14, 2023. It was unanimously recommended that the Barton County Commission approve this request. Due to the height of the tower, there is one condition of approval recommended, that no building permit be issued to construct the tower until the FCC approvals have been received. The FAA approvals have been submitted.

Judy Goreham, Environmental Manager, said she was asking for approval of a brand-new communications tower proposed to be located directly south of the golf course, west of Highway 281, across from Barton Hills. The land was owned by the Haberman Trust, Patricia Haberman and her son, Patrick Haberman, were present. The proposed tower would be 375' tall with a 10' lightening rod for a total height of 385'. It will be triangular shaped with anchors and the area surrounding the tower was just over 10 acres. Goreham said no neighboring landowners attended the public hearing or voiced any concerns. Communication has frequently dropped in the area, and it would be nice to have better coverage there. Goreham had already received the building permit application and fee so upon approval today, she would issue the building permit. This tower is a T Mobile tower, will be lighted and likely painted, following all FAA and FCC requirements. The lights would blink white during the day and blink red at night. All equipment would be brought in from the Haberman land so that the road to the golf course would not be damaged. After construction, regular maintenance and access will go through an easement on the road.

Commissioner Zimmerman asked Goreham if she heard anything from the golf course. Goreham said no, she did not. Commissioner Zimmerman said it would be nice to have better coverage in the area.

Commissioner Reif said that he agreed with Commissioner Zimmerman and saw no problem with approving the request.

Goreham said as part of the FAA and FCC requirements, flight patterns must be reviewed from Fort Riley as this is a practice area. It was a coordinated effort.

Patricia Haberman said that prior to meeting with Environmental Management, they met with the golf course and Wheatland Electric who made suggestions.

RESOLUTION 2023-23

RESOLUTION FOR APPROVAL OF CONDITIONAL LAND USE PERMIT FOR A DESCRIBED TRACT OF LAND

WHEREAS, on January 28, 2013, the Barton County Planning Commission recommended to the Board of Barton County Commissioners the adoption of the Barton County Zoning Regulations, including the Official Zoning Map of Barton County, Version II. Said recommendation resulting in the adoption of the current version of the Zoning Regulations; and

WHEREAS, on the 14th day of September, 2023, the Planning Commission approved a recommendation to the Board of County Commissioners to take action on conditional land use of a certain tract of land; and

WHEREAS, the Barton County Planning Commission recommends that:

The tract of land situated in the NE/4, Section 29, Township 18 South, Range 13 West in the County of Barton, State of Kansas, more specifically located as follows: 673B N US 281 HWY, Great Bend, KS 67530.

Currently zoned as Agricultural Distract shall be Approved for VB BTS II, LLC by Network Connex; Victor McAlister a Conditional Land Use Permit to construct a 385' Guyed Communications Tower on 10.8 +/- acres of an existing 193.4 +/- acre tract as described above and located on the west side of N US 281 HWY and just south of the Lake Barton Golf Club, contingent upon receiving the FCC approval – As said conditional use is allowed under the Barton County Zoning Regulations, Version II, Article III, District Regulations, Part 1. Agricultural District, Section 3-101 (B) Conditional Uses (2) Communication Towers.

NOW, THEREFORE, the Board of County Commissioners of Barton County, Kansas, hereby adopts the recommendation of the Barton County Planning Commission as contained herein; and

FURTHER, that the Secretary of the Planning Board is hereby directed to have said revision reflected in the official zoning records of Barton County and that a method be established for tracking this, and future actions taken in zoning areas.
