I. OPENING BUSINESS:

A. PROCLAMATION 2023-14: National Author's Day:

-Elizabeth Danielle Coles, Druschel LLC Media, has asked that the Commission adopt a Proclamation recognizing National Author's Day. Celebrated each November 1st, this is a day to honor and appreciate the contributions of authors, both past and present, who have enriched lives through their creative works.

Elizabeth Danielle Coles, Druschel LLC Media, said E.D. Coles was her pen name. Coles read a poem that she wrote for the commissioners titled "First Frost". She spoke about the importance of authors in everyone's lives. Since man had put handprints on cave walls, we have had the need to pass on our knowledge to others and we do that by writing. Coles recognized Dale Hogg and Mike Courson for putting their hearts and souls out there for all of us to read. Coles also recognized some author friends who were not able to be present, Timothy Pennington and Rhea Grandon. Coles acknowledged Diana Watson for writing the proclamation. She read the proclamation and invited some authors present at the meeting to speak.

Becky Gillette said she had been writing with a newspaper for quite some time. She finds it an exciting and exhilarating profession. She writes a column for the Ellinwood Leader and decided to turn it into a book called Jessie's Corner. The term author encompasses a vast array of people who write. There was just something about putting yourself on paper.

Dorian Howton said books, she liked them all. She started reading at three and a half years of age and had not stopped since. easily reads a book a week and none of that would be possible without authors. Howton has her own website for the development and tourism of Ellinwood, Kansas.

Gene Manweiler, former owner of Manweiler Chevrolet in Hoisington, said he never considered himself much of an author but three years ago yesterday, was the last time he walked through Manweiler Chevrolet and locked the door. He thought what better way to preserve that than to write a book. Manweiler said writing the book helped to preserve his family's history. It tells how they made it through the depression, the bankruptcy of General Motors, stressful lives of being a dealer. He was the fourthgeneration owner, had the fifth-generation set up to take over and things changed. The sixth-generation worked for him for two summers and then decided they wanted to go a different route. I was then sold to Micah Ehler. Manweiler said he wrote the book for his family more than anything. He thanked E.D. Coles.

Coles thanked the commissioners for their consideration.

Commissioner Reif said he had two signed copies of Manweiler's book.

B. COUNTY ENGINEER: Consideration of Bids for NE 130 Avenue RCB Extensions:

-Barry McManaman, County Engineer, will present details. Bids were opened on October 20, 2023, for this project which widens an existing Reinforced Concrete Box (RCB) on NE 130 Avenue just north of NE 130 Road. L&M Contractors, Inc. submitted the only bid in the amount of \$73,745.00. The Commission is asked to consider approval of the bid.

Barry McManaman, County Engineer, said the project was one and a half miles north of Claffin. This was primarily a safety improvement and would add six feet on each side. L&M Contractors was the only bid received for the amount of \$73,745.00. If awarded the bid, they would like to start possibly mid-November and could be completed by the end of the year.

Commissioner Hutchinson said they covered this in study session.

Commissioner Zimmerman said it was a good price.

Commissioner Reif said there was a lot of oilfield and agricultural traffic and that road, widening the road would make it much safer.

Commissioner Esfeld moved to accept the \$73,745.00 bid from L&M Contractors, Inc. for the NE 130 Avenue RCB Extensions. Cost to be paid from the Special Bridge Fund, Construction Related Items Line, 003-92-6191-02. Direct the Commission Chairman to sign the Notice of Award and the Agreement between the County and L&M Contractors, Inc. Commissioner Reif seconded the motion.

All voted aye. Motion passed.

C. EMERGENCY ROOF REPAIR: Barton County Sheriff's Office:

-Matt Patzner, County Administrator, will present details. In July of this year, certain County buildings sustained damage as a result of the hailstorm. Included therein is the roof on the Sheriff's Office Administrative Building. After insurance adjusters inspected the roofs, it was suggested that repairs be made. The Commission will consider authorizing Summit Roofing to repair the roof, provided that the work can be completed within the calendar year.

Matt Patzner, County Administrator, presented details and asked for authorization to have Summit Roofing do the repairs provided the work be completed within the calendar year.

Commissioner Hutchinson said if the work could not be completed in this calendar year, they would open it up for bids next year as it would no longer be an emergency repair.

Commissioner Schlessiger moved to authorize Summit Roofing to repair the roof at the Sheriff's Office Administrative Building. Said authorization based on the work being completed prior to December 31, 2023. Cost of the work by Summit Roofing and Exteriors, \$23,578.13, to be paid from the Capital Improvement Fund, Building and Fixed Equipment – General Line, 071-00-6305, with reimbursement to be made through the County's insurance. Should the work not be completed, the authorization will be withdrawn and the County will let a bid for the work.

Commissioner Reif seconded the motion.
