Commissioner Hutchinson said joint meetings were being planned for Hoisington, Ellinwood and potentially Claflin.

# B. CITY OF GREAT BEND CITY COUNCIL AND BARTON COUNTY COMMISSION JOINT MEETING: Courthouse Landscaping Upgrades:

-Jolene Biggs, Council Member, City of Great Bend, will present details. The City of Great Bend has joined with Master Gardeners to request \$5,000.00 for a beautification project on the west side of the Courthouse. Included will be trees, bushes and flowers anchored by the Jack Kilby statue.

Jolene Biggs, Council Member, City of Great, said redoing the landscaping was discussed at the joint meeting. Biggs introduced those involved and heading the project: Jan Keeley, Mark Rondeau and Michelle Rondeau.

Commissioner Hutchinson said they had implemented the Façade Improvement Program and it would be silly to not take care of the area around the courthouse.

Biggs said with the HVAC renovation, they may have to work around construction workers. With it being late in the season, what may be planted could be affected by the heat.

Commissioner Zimmerman said this would be the initial landscaping that the Master Gardeners would maintain. Biggs said that was correct.

commissioner Schlessiger said she appreciated the Master Gardeners taking the role of maintaining the landscaping.

Jan Keeley said the Master Gardener Program had to provide an educational component. There would be a very small plaque and identification by each different plant that could be scanned to learn about the plant and how to care for it.

Commissioner Esfeld moved to approve a \$5,000.00 match to the City of Great Bend for Courthouse Landscaping Upgrades. Cost to be paid from the Capital Improvement Fund, Improvement Not Buildings – General Line, 071-00-6310.

# C. CITY OF GREAT BEND CITY COUNCIL AND BARTON COUNTY COMMISSION JOINT MEETING: Operation Clean Sweep:

-Chief Steve Haulmark, City of Great Bend, will present details. This discussion was a topic at Thursday night's meeting. Essentially the County will consider financial assistance for the City's Operation Clean Sweep. This is essentially a community service program that was developed to alleviate trash, refuse and blight from the community.

Chief Steve Haulmark, City of Great Bend, said prior to coming to Great Bend, he worked 25 years at Kansas City, Kansas Police Department. In his duties in Community Policing, they had a project like Operation Clean Sweep where they used community service workers to address issues within the community. He wanted to bring that philosophy to Great Bend. Haulmark and a couple of his command staff went to some properties that came up during code abatement. They were able to abate six properties in three hours. When people see trash or blight, it can translate to a feeling that an area was bad or unsafe. Evidenced based policing offers practical solutions that balance public safety, community service needs, available funds and taxpayer expectations. Trying to control crime while removing the

Dight as well as helping citizens. They work with Code Enforcement in identifying the properties. They want to help the elderly and those unable to care for the property themselves. They are utilizing criminal justice individuals who asked to be a part of the program in lieu of paying fines. They work on Saturday from 9:00 to 1:00 and receive \$10.00 an hour credit to go towards the fines owed. If the individual works extra hard, they receive more credit. This also allows the officers to interact with the individuals on a different level and build a rapport. Over 10 ½ tons of trash had been cleaned up at the river with more work to be done.

Commissioner Hutchinson asked if Project Clean Sweep stopped at the city limits.

Haulmark said it does not, we are all the same community. Haulmark added that right now they were using Municipal Court community service workers, but they would welcome more individuals. People do have to apply for the program, understand the expectations and be accepted. The workers are tracked, signed in and signed out each time.

Commissioner Schlessiger asked if Central Kansas Community Corrections clients could be involved. Haulmark said they could. The requirements were that they be at the Police Department by 9:00 A.M., willing to work and sober.

Commissioner Esfeld said it was a great program and allowed individuals to give back to the community.

Commissioner Zimmerman moved to approve a \$5,000.00 match to the City of Great Bend for Operation Clean Sweep contingent upon an equal or greater match by the City of Great Bend. Cost to be paid from the Capital Improvement Fund, Improvement Not Buildings – General Line, 071-00-6310. Commissioner Schlessiger seconded the motion.

D. BARTON COUNTY FAIR BOARD: Upgrades to Expo III:

-Matt Patzner, County Administrator, will provide details. In their 2023 budget request, the Barton County Fair Association detailed a need to improve emergency exits and lighting as well as accessibility. With the upgrades made, the Fair Association requests that the County contribute \$5,000.00 to the \$7,969.33 project. In addition, the Commission will consider providing \$500.00 to the Fair Association to increase radio advertising.

Matt Patzner, County Administrator, presented details.

Kate Wary, Fair Board, said to clarify, the improvements had not yet been made but they did have to write the check. The improvements must be made prior to the fair opening because it was not up to code.

Commissioner Hutchinson said he and Patzner had talked about the amount the board needed versus what they had asked for and had been trying to figure out the numbers.

Patzner said the initial request was \$5,000.00, that was the estimate at the time.

Wary said she would amend the request if the commission were willing to do more. They were appreciative of anything offered.

Patzner said this was separate from their budget request. The 2023 budget request was for what the county statutorily had to cover.

Commissioner Schlessiger moved to approve a \$7,969.33 disbursement to the Barton County Fair Association to assist with the Expo III upgrades and current, oh, and current radio advertising. Commissioner Hutchinson said an additional \$500.00.

Jommissioner Schlessiger continued her motion, so I need to add an additional \$500.00 to that. The disbursement to be made from the Finance General Account of the General Fund, Barton County Fair Association Line, 001-26-6850. Is that clear.

Commissioner Hutchinson said let's go for a second.

Commissioner Zimmerman seconded the motion.

Commissioner Schlessiger said they wanted to do the additional funding for advertising because this would be the only carnival in Barton County this year.

Commissioner Zimmerman asked Commissioner Schlessiger if her motion included radio and/or print advertising.

Commissioner Schlessiger said it did.

All voted aye. Motion passed.

#### E. CABB ELEVATOR: Elevator Remodel Contract:

-Mr. Patzner will provide details. For some time, the Courthouse has experienced service interruptions in relation to the elevator. It has been suggested that part of the problem is due to the mechanics being housed on the roof. The County has received an Elevator Remodel Contact to modernize the unit. Included in the \$122,300.00 cost is electrical components, power unit, wiring, hydraulic oil, piston and cylinder. It is suggested that Capital Improvement funds be used for the upgrade.

Matt Patzner, County Administrator, said they also solicited a quote from KONE. That quote was \$110,300.00 and did not include replacement of the jack. They estimated that to be an additional \$70,000.00 - \$100,000.00 on top of their quote.

Patrick Hoffman, County Counselor, said it had been approved for tax credits. Patzner said it would be for 30%.

Commissioner Zimmerman said that included a year of maintenance. Patzner said yes, it did.

Commissioner Schlessiger asked how much a month maintenance cost. Patzner said currently around \$50.00 per month.

Commissioner Reif said the elevator project was not initially planned but would be a good time to do it while the building was empty. It would add around 50 years to the life of the elevator.

Commissioner Reif moved to approve the Elevator Remodel Contract with CABB Elevator. Direct the County Administrator to encumber \$122,300.00 from the Capital Improvement Fund, Buildings and Fixed Equipment – General Line, 071-00-6305.

Commissioner Esfeld seconded the motion.

All voted aye. Motion passed.
